

## Higher Education Emergency Relief Fund Report – Emergency Financial Aid Grants to Students

September 30, 2021

West Virginia Junior College (OPEID-01057300) received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”), Public Law No: 116-136 and under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (“CRRSAA”) Public Law 116-260, Section 314 (a)(4). This final fund Report applies to the student portion received under the Higher Education Emergency Relief Fund I and the entire portion of the Higher Education Emergency Relief Fund II that is designated exclusively for emergency financial aid grants to students.

The institution appreciates that Congress and the President have made these critical funds available for eligible students who have expenses related to the disruption of campus operations due to the coronavirus pandemic. We take receipt of these federal funds seriously and are distributing them in accordance with the CARES Act and implementing guidance.

### CARES Act

1. The institution signed and returned to the Department the Certification and Agreement [for] Emergency Financial Aid Grants to Students. The institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide emergency financial aid grants to students.
2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution’s Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$235,208.
3. The total amount of emergency financial aid grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is **\$233,548.00\*\***. The balance of **\$1660.00** in funding was returned on September 10, 2021.
4. The estimated total number of students at the institution eligible\* to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, and thus

5. The total number of students who have received an emergency financial aid grant under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is **249**.
6. The methods used by the institution to determine which students receive emergency financial aid grants and how much they would receive under Section 18004(a)(1) of the CARES Act are provided at **Attachment A**. The institution ultimately awarded a maximum award of \$1,100 and minimum of \$650 based on the methodology in Appendix A.
7. Any instructions, directions, or guidance provided by the institution to students concerning the emergency financial aid grants are provided at **Attachment B**.

### CRRSAA Act

1. The institution signed, and returned to the Department, the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA (a)(4) programs to provide Emergency Financial Aid Grants to Students.
2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA (a)(4) is \$270,702.00.
3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA (a)(4) programs is \$0. The institution elected to return all funding on September 10, 2021.
4. The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA (a)(4) was not determined due to the return of funds.
5. The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA(a)(4) program is 0.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA (a)(4) program were determined by the institution because the funds were returned.
7. There will not be any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants have not yet been released by the institution because the funds were returned.

## Appendix A

### Higher Education Emergency Relief Grant Methodology for Awarding and Disbursing (HEERF I)

The institution has established the following methodology for awarding and disbursing the 50% student share of the Higher Education Emergency Relief Funds.

Because COVID-19 does not discriminate by income, the institution believes the most fair and equitable way to award these grants is to consider the expenses a student has incurred due to the disruption of campus operations as they relate to a student's Cost of Attendance rather than by a student's expected family contribution yielded from the FAFSA.

In an effort to award funds to all students that are impacted by the Coronavirus pandemic, the institution will award funds as follows:

80% of the allocation will be awarded to eligible students as of the beginning date of the application period.

20% will be reserved for new starts between the months of May 1, 2020 and June 30, 2020.

Furthermore, to streamline awarding so it is more transparent to the student and to reduce tabulation burden and enable the institution to disburse funds in the quickest allowable timeframe, funds will be awarded in the following categories:

Award Levels	On Campus/Hybrid Degree and Diploma Program Students
Maximum Awards*	\$1,000.00
Minimum Awards*	\$600.00

\* These maximum and minimum amounts may change either up or down after the application period has ended based on the number of applicants and the award level of each as outlined in the institution's methodology.

If a currently enrolled student is awarded, he/she will receive two disbursements: One will be disbursed immediately in an amount equal to 75% of the total award. Because the institution anticipates disruptions in campus operations in the coming months, the remaining 25% will be disbursed at the beginning of the student's next module. If a recent eligible graduate (or an upcoming graduate at the end of the summer terms) is awarded, he will receive the entire award in one disbursement.

### Eligible Students

All students that graduated after March 13, 2020 (the date of the Proclamation of National Emergency by the President of the United States) and all students attending classes as of March 13, 2020 in any on ground and or hybrid degree or diploma program are encouraged to apply for the HEER Grant. As stated above, new students who start classes during the months of May 1,

2020 through June 30 will also be eligible. Applications will be forwarded to these students upon starting classes.

Only Title IV students are eligible for the HEER Grant. Students that have completed the FAFSA and have been awarded federal student aid funds will be eligible if they apply. In addition, if a student's tuition and fees are being paid for by another source other than Title IV federal student aid and the student did not complete a FAFSA, that student may still be eligible for the HEER Grant and will be instructed to contact the Financial Aid Office so we can help determine if the student would otherwise have been eligible.

### **Application Deadline**

To ensure prompt distribution of HEER Grant Funds, the institution has established an application deadline of 10 days from the date the application was emailed to the student.

### **Methodology**

The institution did not include the Tuition and Fees component or Transportation Costs in this methodology. Guidance has been clear that these grants should not be utilized to pay for Tuition and Fees. Transportation was not considered since students are not commuting to and from campus during the COVID-19 pandemic. The Cost of Attendance components factored into the awarding of HEER grant funds are:

1. Room and Board
  - a. Rent/Mortgage
  - b. Groceries and Household Supplies
  - c. Utilities
2. Books/Supplies/Other
  - a. Laptop/Computer
  - b. Internet
  - c. Phone Bill
  - d. Health Care
  - e. Childcare

Expenses attributed to the impact of the Coronavirus pandemic impact the entire household. Therefore, the institution chose to utilize the Living Off Campus Without Parents Cost of Attendance components. The dollar amounts of the two main components of the cost of attendance as reported to IPEDS in the Institutional Characteristics survey are given a weighted percentage based on the following formula:

This is an illustration of one campus in the organization's structure but percentage results across all campuses are the same):

Room and Board:     \$8169.00

Books and Supplies: \$384.00 + \$600.00 (This is an additional reasonable amount for a laptop)

Other: \$4665.00

**Total: \$13,818**

Room and Board is roughly 60% of the considered components with Books, Supplies, and Other consuming the other 40%.

Next, the Sub-components were weighted based on a general percentage of the components total as follows:

Room and Board	60%
Rent/Mortgage	25%
Groceries and Household Supplies	25%
Utilities	10%
Books/Supplies/Other	40%
Lap Top/Computer	20%
Internet	10%
Phone Bill	10%
Health Care	5%*
Childcare	5%*

\*These subcategories are not typically included in the institution's Cost of Attendance but rather added on in a case-by-case basis. Therefore, these are weighted low and cause the total percentage to be over 100%.

All Students will be emailed a Higher Education Emergency Relief Grant Student Application. The application asks the students if they have incurred an expense due to the disruption of campus operations due to COVID-19. If they respond yes, they are instructed to check each area in which they have been impacted.

The application will be tabulated by totaling each percentage in the categories in which the student indicated they have been affected. For example, Student A indicated she was impacted with Groceries and Household Supplies, Laptop, and Internet. The total of each of these categories is  $25\% + 20\% + 10\% = 55\%$ .

Awards are then determined as follows to the total percentage from a student application:

Degree and Diploma Program:

50% to 110% = \$Maximum Award

5% to 49% = \$Minimum Award

These maximum and minimum amounts may change either up or down after the application period has ended based on the number of applicants and the award level of each as outlined in the institution's methodology.

## **Tabulation**

Each application returned to the institution will be transferred to a spreadsheet that has formulas imbedded that will add percentages and assign awards based on the methodology outlined above. This spreadsheet will also be utilized to complete required reporting to ED.

NOTE: The student is also being asked if their income/job has been affected by COVID-19. An affirmative answer to this question without indicating expenses have been incurred will result in no award of HEER grant funds. The student will need to also indicate he has incurred expenses.

If a student does indicate income/job has been affected, the application will be forwarded to the financial aid office to determine if a professional judgment is warranted.

## Appendix B

### Higher Education Emergency Relief (HEER) Grant Information for Students

The Federal Government has made available emergency grant funds for students impacted by Coronavirus as authorized in the Coronavirus Aid, Relief, and Economic Securities Act (the CARES Act). These funds are grants created by the CARES Act and are not required to be repaid. The funds are also not part of your financial aid package and therefore, will not affect you current awards.

#### Application Process

Students currently enrolled at the institution and students who graduated after March 13 (the date of the Proclamation of National Emergency) will be emailed an application for the HEER Grant. To be considered for the HEER Grant, a student must complete the application, sign it electronically, and submit to the institution within 10 days of the application being emailed. By signing the application, the student is attesting that the information supplied related to expenses is true and accurate. The student is also attesting that the funds are needed to help cover expenses related to the disruption of campus operations that have impacted the student's enrollment at the institution. The application will be automatically forwarded back to the institution if the student completes the application electronically using a smart phone or computer.

The student may be asked to provide additional documentation to support his/her claim of increase in expenses due to the Coronavirus pandemic.

#### Award Amounts

Students will be awarded based on the responses in the application. The areas in which the student indicates he/she has been impacted will be ranked and recorded based on methodology determined by the institution. This methodology will ensure the grant funds are awarded and distributed in the most equitable manner possible and to as many students as possible. Students may request to review this methodology by contacting the financial aid office at his/her campus of enrollment.

## **Eligible Students**

All students that graduated after March 13, 2020 (the date of the Proclamation of National Emergency by the President of the United States) and all students attending classes as of March 13, 2020 in any on ground and or hybrid degree or diploma program are encouraged to apply for the HEER Grant. New students who start classes during the months of May 1 through June 30, 2020 will also be eligible. Applications will be forwarded to these students upon starting classes.

Only students receiving federal student aid funds are eligible for the HEER Grant. Students that have completed the FAFSA and have been awarded federal student aid funds will be eligible if they apply. In addition, if a student's tuition and fees are being paid for by another source other than federal student aid and the student did not complete a FAFSA, that student may still be eligible for the HEER Grant. Please contact the Financial Aid Office so we can help determine if the student would otherwise have been eligible.

## **Application Deadline**

To ensure prompt distribution of HEER Grant Funds, the institution has established an application deadline of 10 days from the date the application was emailed to the student.

## **Disbursements**

In an effort to award funds to all students that are impacted by the Coronavirus pandemic, the institution will award funds as follows:

80% of the allocation will be awarded to eligible students as of the beginning date of the application period.

20% will be reserved for new starts between the months of May 1 and June 30, 2020.

If a currently enrolled student is awarded, he/she will receive two disbursements: One will be disbursed immediately in an amount equal to 75% of the total award. Because the institution anticipates disruptions in campus operations in the coming months, the remaining 25% will be disbursed at the beginning of the student's next module. If a recent or upcoming eligible summer graduate is awarded, he will receive the entire award in one disbursement.

## **Special Note Regarding Loss/Reduction of Income**

Students are asked on the application for HEER Grants if anyone in the household has had changes to income due to the Coronavirus pandemic. A change in job circumstance by does not qualify a student for the HEER Grant (See next paragraph). The student must also indicate on the application that he/she has actual expenses related to the disruption of his/her enrollment due to the Coronavirus Pandemic.

If the student or anyone in that student's household (that is included on the FAFSA) has experienced a change in job situation, he/she should communicate with the financial aid office at

the institution to see if an adjustment can be made to your award package. Keep in mind however, these adjustments are only made on a case-by-case basis and only if acceptable documentation to support the claim is included.
